The WFE Principles for Sustainable Exchanges

In the November 2017 UN Environment – World Bank Group Roadmap for a Sustainable Financial System the authors note that "sustainable growth will be one of the greatest challenges of the 21st century" and that "the full potential of the financial system needs to be harnessed to serve as an engine in the global economy's transition toward sustainable development". The Principles form part of the exchanges' contribution. Why is this something that market infrastructures should be looking at? How does this interact with the rest of the financial system? What role is there for multilaterals? Data availability, consistency and credibility is central to achieving many of the objectives set out in the Sustainable Development Goals and indeed the Principles – what do we need to do to get us there? How do we align differing perspectives on sustainability, and different investor views on how they approach ESG and sustainability, with index products and other sustainability-related products? How do smaller markets, where issuers and investors are perhaps less convinced of the relevance of these issues, address these?

Exchanges have to balance the needs of multiple stakeholders including regulators, the buyside, issuers, trading participants and government. Exchanges also have to find the midpoint that promotes market development while still ensuring appropriate investor protection. How can they balance these sometimes-competing demands and how do they appropriately align incentives to come to market with the costs? What is the debate around ICOs telling us about balancing investor protection with regulated markets? How do we encourage more companies to list on well-regulated, transparent public markets when, for example, family-run businesses say their greatest concern is losing control? How

do we avoid the adoption of a tick-box approach to corporate governance and get to a focus on substance, rather than form? Do we need global standards?

Thinking About ETFs: Too Hot? Too Cold? Just Right?

Exchanges, asset managers and regulators unite in the ETF market – an industry that has seen record-breaking investor inflows in recent years, innovation and, consequently, fresh regulatory scrutiny. Listed ETF/ETP assets topped US \$5 trillion in May 2018, and have experienced a CAGR of nearly 19% over the last 10 years. Does the ETF market pose a new challenge to financial stability? Where is the growth coming from and why are they so popular today? What questions does the growth of synthetic ETFs pose for counterparty and credit risk? Do ETFs make the market more volatile? What implications does the growth have for liquidity on markets, especially in times of market stress? How can exchanges and investors balance the benefits of ETF listing with the challenges?
