#### 12:15 – 13:15 Session 3: Market Liquidity: The Devil is in the Detail

"When I hear complaints about less liquidity, remember there is such a thing as too much liquidity." (Paul Volcker). While resilient and dynamic markets are made possible by exchanges and CCPs, well-functioning markets need liquidity to serve their purpose. What makes liquidity fragment on exchange-traded markets? How can exchanges and CCPs overcome these challenges? Is competition a help or a hindrance in fragmenting liquidity? In a world that is fragmenting politically and legally what can exchanges and investors really do to turn the tide? As the G20 and FSB look for examples and solutions of how fragmenting regulation is impeding markets, what can the ecosystem point to? What can regulators, market infrastructures, brokers and investors do? And as exchanges and investors worry about liquidity - finding it, keeping it, growing it - can Volcker ever be right?
